**BY THE COMMISSION:**

On May 2, 2014, Time Warner Cable Information Services (Arizona), LLC, dba Time Warner Cable ("TWCIS"), Time Warner Cable Business LLC, dba Time Warner Cable ("TWCB"), and Comcast Phone of Arizona, LLC, dba Comcast Digital Phone filed an Application at the Arizona Corporation Commission ("Commission") requesting a limited waiver of the Affiliated Interest Rules or, alternatively, expedited approval of Comcast Corporation's proposed indirect acquisition of TWCIS and TWCB as a result of its merger with Time Warner Cable Inc.


On June 30, 2014, the Commission's Utilities Division ("Staff") docketed a Memorandum stating that pursuant to Arizona Administrative Code R14-2-806(C), the waiver became effective on the 31<sup>st</sup> day following the Application's filing, which was June 2, 2014 in this matter. Accordingly, Staff recommended that the dockets be administratively closed.

Staff's recommendation is reasonable and should be adopted.


