15 Pursuant to the Rules of Practice and Procedure of the Arizona Corporation Commission  
16 (“Commission”), Western Resource Advocates (“WRA”) hereby moves to intervene in the  
17 above-captioned docket and, in support thereof, states as follows:

18 1. WRA is a non-profit regional environmental law and policy center serving the  
19 Rocky Mountain and Desert Southwest states. WRA has been involved in proceedings before  
20 the Commission since about 1990 and has been granted intervenor status in numerous dockets.  
21 WRA has staff members and multiple supporters who live and recreate in Arizona and/or are  
22 customers of Arizona electric utilities.

24 2. WRA’s Energy Program promotes policies and programs designed to encourage  
25 the development of clean energy technologies, energy efficiency, renewable resources,

1 distributed generation, and other measures that help reduce the environmental impacts of  
2 meeting the demand for energy services, while minimizing costs and risks to ratepayers.

3 3. Intervention by WRA will not unduly broaden the issues or delay the proceeding.

5 be served on the following:


