On December 31, 2013, Johnson Utilities, LLC dba Johnson Utilities Company (“Johnson Utilities” or “Company”) filed an application for approval of the sale and transfer of all of the Company’s utility assets and operations in Pinal County, Arizona to the Town of Florence (“Town”) and the cancellation and extinguishment of the Company’s Certificate of Convenience and Necessity.

On May 23, 2014, Johnson Utilities filed a Motion to Withdraw Application, stating that the sale and transfer to the Town will not be moving forward. On June 10, 2014 Staff filed its Response to the Motion, stating that they have no objection to the Motion.

Per the Procedural Order issued on June 18, 2014 by Teena Jibilian, Administrative Law Judge, the Motion to Withdraw Application filed on May 23, 2014 is granted. Therefore, this docket is administratively closed.
