ORDER AMENDING DECISION NO. 74445

Open Meeting

Phoenix, Arizona

BY THE COMMISSION:

The Commission approved new rates and charges for Cibola Mutual Water Company ("Cibola" or "Company") in Decision No. 74445, entered on April 18, 2014. Decision No. 74445 provides that the new rates and charges will go into effect on the first day of the month following the filing of a notice of compliance with the Arizona Department of Environmental Quality ("ADEQ"). On May 27, 2014, the Company filed a request to modify Decision No. 74445 to permit the Company to begin charging the new rates and charges in July 2014 because of serious financial concerns that adversely impacts its continued operation.

Cibola's request was placed on the Commission's June 10, 2014 Staff Open Meeting agenda with notice and an opportunity to be heard. After considering the Company's request, the Commission voted to modify Decision No. 74445 to permit Cibola to begin charging the new rates and charges in July 2014. As a compliance matter, the Commission also ordered that Cibola shall docket a status report delineating its ADEQ compliance status within six months of the effective date of this decision, and every six months thereafter until further notice of the Commission.

1 IT IS THEREFORE ORDERED that Decision No. 74445 is hereby modified to permit Cibola
2 Mutual Water Company to begin charging the new rates and charges approved in Decision No. 74445
3 for all bills issued on or after July 1, 2014.



4 IT IS FURTHER ORDERED that Cibola Mutual Water Company shall notify its customers
5 of the new rates and charges and their effective date, in a form acceptable to the Commission's
6 Utility Division Staff, by means of an insert in its next regularly scheduled billing.


7 IT IS FURTHER ORDERED that the Cibola Mutual Water Company shall as a matter of
8 compliance docket a status report delineating its Arizona Department of Environmental Quality
9 compliance within six months of the effective date of this decision, and every six months thereafter
10 until further notice of the Commission.

11 IT IS FURTHER ORDERED that the provisions of Decision No. 74445 not specifically
12 modified herein continue to remain in effect.


13 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
