RE: Docket No. ~~E-01345A-13-0248~~ – In the Matter of Arizona Public Service Company’s Application for Approval of Net Metering Cost Shift Solution

To all Stakeholders:

On July 22, 2014, the Commission voted to reopen Decision No. 74202 pursuant to A.R.S. Section 40-252 for the purpose of considering the possibility of modifying Decision No. 74202 to remove the requirement that Arizona Public Service Company (“APS”) file its next general rate case in June 2015. The proposed modification under consideration would delete the following ordering paragraph: “It is further ordered that APS shall file its next general rate case in June 2015, consistent with the provisions of Decision No. 73183.” Stakeholders interested in these matters are invited to submit their filings in Commission Docket No. E-01345A-13-0248 by August 7, 2014. The filings should address the merits of possible modification of Decision No. 74202 to eliminate the requirement that APS file its next general rate case in June 2015, and should suggest appropriate procedural processes for Commission consideration of this proposed modification. Also, stakeholders should address whether there would be benefits related to Commission consideration of net metering rate design issues in generic proceedings. In addition, the stakeholders’ filings should respond to the following questions:

1. Should net metering rate design issues be considered in Docket No. E-00000J-14-0023 (*In the Matter of the Commission’s Investigation of Value and Cost of Distributed Generation*)? If not, why not?
2. Regardless of any net metering rate design issues, why should APS be required to file a general rate case prior to the time APS believes it is under-earning or the Commission is concerned that APS may be over-earning?

It is anticipated that the Commission will consider these matters at its August Open Meeting currently scheduled for August 12-13, 2014, and that it will provide an opportunity to be heard. Stakeholders should check the open meeting agendas posted on the Commission’s website for specific information about the date and time these matters will be scheduled.
