NOTICE OF FILING

In Decision No. 71869, Granite Mountain Water Company, Inc. ("Granite Mountain" or "Company") was ordered to file a permanent rate case application within two years of the effective date of that Decision. In Decision No. 73155, the filing deadline was extended to September 20, 2013. In Decision No. 74384, that deadline was again extended, this time to June 30, 2014, and the Company was ordered to use a test year ending December 31, 2013.

On June 30, 2014, the Company filed its Notice of Filing Rate Application. The Utilities Division Staff ("Staff") reviewed that application and determined that it did not meet the sufficiency requirements as outlined in Arizona Administrative Code R14-2-103. Staff issued a Letter of Deficiency on July 24, 2014, giving Granite Mountain until August 8, 2014, to correct the deficiencies or make other arrangements with Staff to remedy the rate application.

Granite Mountain has requested, and Staff has agreed, that the deadline for correcting deficiencies to the rate application shall be extended to August 25, 2014.
