Respondents MOVE for an Order further extending the date for filing Respondents' Post-Hearing Brief from August 12, 2014 to August 18, 2014 due to the medical issues Respondents' counsel has experienced, as described below.


Respondents' undersigned counsel now has had cataract surgery replacing the lenses in both his eyes. His second eye surgery was done on Monday, August 4, 2014, replacing the lens in his left eye. Although that eye is healing well, as determined by his ophthalmologist during a post-operative examination

yesterday, August 11, 2014, yesterday was the first day following that surgery during most of which his left eye was not largely useless due to a white-out like fog, making reading and writing very difficult – much more difficult than counsel remembered experiencing with his right eye’s recovery earlier, although his ophthalmologist yesterday indicated that he had complained of the same condition with his right eye, which lasted a little more than one week. As noted in Respondents’ counsel’s initial request for an extension, cataract surgery had not been recommended by his ophthalmologist or scheduled at the time the briefing schedule was agreed. Counsel began having serious vision problems during March and had to wait until after the Hearing to attend to them.

Although the Hearing was concluded on May 1, 2014, Division’s counsel requested, based on his schedule, that the Division’s opening brief due date be extended to June 21, 2014, a much longer period than is usual. Respondent’s counsel, out of courtesy, immediately agreed. Undersigned counsel now needs several more days (four business days) to finish Respondents’ Post Hearing Response Brief, due to his medical condition.
