BY THE COMMISSION:

On March 25, 2013, the Arizona Corporation Commission's ("Commission") Utilities Division ("Staff") opened the above-captioned generic Docket at the request of the Commission.

On April 30, 2014, Southwest Energy Efficiency Project ("SWEEP") filed a Motion to Intervene and by Procedural Order, on May 12, 2014, SWEEP was granted intervention.

On May 16, 2014, the Residential Utility Consumer Office ("RUCO") filed an Application to Intervene and by Procedural Order, on May 30, 2014, RUCO was granted intervention.

On June 11, 2014, the Arizona Competitive Power Alliance (the "Alliance") filed an Application for Leave to Intervene and by Procedural Order, on June 23, 2014, the Alliance was granted intervention.

On July 3, 2014, Western Resource Advocates ("WRA") filed a Motion to Intervene and by Procedural Order, on July 14, 2014, WRA was granted intervention.

On July 10, 2014, Gila River Power, LP ("GRP") filed an Application for Leave to Intervene and by Procedural Order, on July 21, 2014, GRP was granted intervention.

On July 28, 2014, Freeport-McMoRan Copper & Gold, Inc. ("Freeport-McMoRan") and Arizonans for Electric Choice and Competition ("AECC") filed an Application for Leave to Intervene.


