STAFF'S SUPPLEMENT TO REQUEST TO EXTEND THE DATE FOR INTERVENTION

The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") files this supplement to its Motion to Extend Time for Intervention filed on August 14, 2014.

In that Motion, Staff had requested that the time for extension be limited to the EPCOR Water Arizona Inc. ("Company") Mohave wastewater customers. Upon further reflection, Staff wishes to withdraw that limitation and would suggest that the time for intervention be extended for any person or entity with an interest in the Company's wastewater rates.

In Docket No. SW-1303A- 09-0343, there is the potential that the Company's wastewater customers in the districts that are included in that docket (Anthem, Aqua Fria, Sun City and Sun City West) will be asked to pay consolidated rates that will include the revenue requirement to be established in the instant docket. As such, all of the Company's wastewater customers should have the opportunity to intervene.


