**MOTION TO CONSOLIDATE**

Global Water – Santa Cruz Water Company (“Santa Cruz”) moves that this docket be consolidated with Docket No. SW-20445A-14-0291. Both dockets are CC&N Applications covering essentially the same area.<sup>1</sup> This docket is for the water CC&N for the extension area, and Docket No. SW-20445A-14-0291 is for the wastewater CC&N for the extension area. The Applicant in Docket SW-20445A-14-0291 is Global Water – Palo Verde Utilities Company (“Palo Verde”), a sister company of Santa Cruz. The applications were prepared jointly, at the request of the same landowners, with the exception of one landowner that did not request water service and is therefore not included in the application in this docket. Santa Cruz and Palo Verde intend to provide integrated water, wastewater, and reclaimed water services to the extension area, as they do in their existing service areas. In addition, consolidation will serve administrative efficiency and reduce legal expenses because only one hearing will be required. Further, many other water and wastewater CC&N dockets have been consolidated in the past.

Lastly, Santa Cruz requests that the caption be modified to delete “, Inc.” from its company name, which was included in error.

<sup>1</sup> There is one small parcel included in the wastewater docket that is not included in the water docket.
