On March 17, 2014, Freeport-McMoRan Copper & Gold Inc. (“Freeport-McMoRan” or “Company”) filed a Request For Exemption From A.A.C. R14-2-2401, *et seq.* in Docket No. E-01345A-13-0109 captioned “In The Matter of the Application of Arizona Public Service Company for Approval of Its 2014 Demand Side Management Implementation Plan”.

On July 8, 2014, Arizona Public Service Company (“APS”) filed a Request for Ruling on Freeport-McMoRan’s Request for an Exemption from A.A.C.
