

In reference to the above docket/case, please support the full consolidation of the five waste consolidation districts to spread the cost equally. It is unfair for Verrado residents to pay such outrageous cost because of the partial de-consolidation that occurred in 2012. Residents cannot afford to pay these rates and it is damaging to the welfare of our community.

The real impacts of the 2012 decision to deconsolidate have been, frankly, disastrous to Agua Fria residents. No amount of conservation will do away with a \$106 wastewater charge (soon to be \$121), and we find ourselves making choices about which essentials to do without or whether to leave altogether. Much has been made of retirees on "fixed incomes." I would urge you to consider the fact that virtually everyone is dealing with earning potential that cannot be increased at will.

Full consolidation is the right decision, not just for Agua Fria but for everyone.
