PROCEDURAL ORDER

BY THE COMMISSION:

On November 6, 2013, Appaloosa Water Company ("Appaloosa" or "Company") filed an application with the Arizona Corporation Commission ("Commission") requesting authorization to incur long term debt from the Water Infrastructure Finance Authority of Arizona in the amount of \$295,000.

On May 30, 2014, the Commission's Utilities Division ("Staff") issued a Staff Report recommending partial approval of Appaloosa's financing application. Staff recommends authorization of only \$41,000 of debt for one emergency stand-by generator with propane tank, subject to certain terms and conditions. The Staff Report indicated that any party wishing to file comments to the Staff Report should file them with the Commission's Docket Control by 4:00 p.m. on or before June 10, 2014.

On June 9, 2014, Appaloosa filed an Affidavit of Mailing.

Appaloosa did not file comments to the Staff Report. Because this matter may proceed without a hearing, it is appropriate to require Appaloosa to file comments to the Staff Report. It is also appropriate to allow Staff time to file a reply to Appaloosa's comments.


IT IS THEREFORE ORDERED that Appaloosa shall file comments to the Staff Report on or before September 11, 2014.

IT IS FURTHER ORDERED that Staff may file a reply to Appaloosa's comments on or before September 18, 2014.

1 IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules
2 31 and 38 and A.R.S. §40-243 with respect to the practice of law and admission *pro hac vice*.

3 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
4 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
5 hearing.


