BY THE COMMISSION:


On July 1, 2014, Tucson Electric Power Company ("TEP" or "Company") filed with the Arizona Corporation Commission ("Commission") its 2015 Renewable Energy Standard and Tariff ("REST") Implementation Plan ("Plan").

On August 21, 2014, the Residential Utility Consumer Office ("RUCO") filed an Application to Intervene. RUCO was created by statute to represent residential utility consumers in matters before the Commission concerning regulated public service corporations.
