PROCEDURAL ORDER

BY THE COMMISSION:

On July 1, 2014, Arizona Public Service Company ("APS") filed with the Arizona Corporation Commission ("Commission") the above-captioned application ("2015 RES Plan").

Intervention has been granted to the Arizona Solar Deployment Alliance.

On August 21, 2014, the Residential Utility Consumer Office ("RUCO") filed an Application to Intervene.

No objections have been filed to RUCO's request for intervention.

IT IS THEREFORE ORDERED that RUCO is hereby granted intervention.

IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules 31, 38 and 42 and A.R.S. § 40-243 with respect to the practice of law and admission *pro hac vice*.

IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Arizona Supreme Court Rule 42). Representation before the Commission includes the obligation to appear at all hearings, procedural conferences, Open Meetings for which the matter is scheduled for discussion unless counsel has previously been granted permission to withdraw by the Administrative Law Judge or Commission.


