RUCO'S COMMENTS TO THE RECOMMENDED OPINION AND ORDER

The Residential Utility Consumer Office ("RUCO") offers its comments in the form of public comment. RUCO submits these comments as it appears that the nature of this docket has moved beyond modifying small utility filing thresholds to a conversation of modifying AAC R14-2-103 as a whole.

RUCO supports the Recommended Opinion and Order ("ROO"). RUCO looks forward to participating in the Rule 103 workshop(s), and believes sections of Rule 103 can and should be modified to support Commissioner Bob Burns' expressed support for having utility companies provide more upfront information in order to process rate cases faster.¹ RUCO believes the process would move faster if companies were required to file more detailed information.

RUCO is not interested in over burdening any company with filing requirements. Rather RUCO seeks to make sure that what the companies are required to file provide the necessary information needed for RUCO and other parties to do their analysis.
