AMENDED APPLICATION TO INTERVENE

The undersigned, Douglas Edwards ("Petitioner"), is a resident of Corte Bella Country Club Association ("CBCCA"), one of the residential areas receiving services from EPCOR Water Arizona, Inc. ("EPCOR"). CBCCA is located in EPCOR's Aqua Fria District. Petitioner is a member of the Government Affairs Committee ("GAC") in CBCCA that organized over 1,300 petitions alerting, and complaining to, the Arizona Corporation Commission ("Commission") that the current water rates in the Aqua Fria District are discriminatory in nature and that EPCOR must address the disparity in rates and offer alternative rate designs or other solutions to mitigate these discriminatory disparities.

Petitioner requests to intervene in this proceeding (along with several other residents from CBCCA and surrounding communities, each of whom will be filing an Application to Intervene) since the current process being undertaken by the Commission was initiated by the petitions organized and delivered to the Commission by this resident group, each of whom has a vested interest in the structure of the water districts in Arizona, especially the Phoenix area. GAC reports to the Governing Board and General Manager of CBCCA and is responsible to communicate the Commission's process to the

community and, in turn, to communicate the position of CBCCA to the Commission. As such, Petitioner requests her application to intervene be approved.
