Comments: The proposal to just about double our water rates is excessive. To apply this increase across the board despite different levels of consumption would be irresponsible. First of all Greenehaven is a small community (approx. 800) that is located right next to a huge water source - Lake Powell. Further, many of the residents are retirees on fixed incomes or low wage earners. Property taxes, Fredonia school taxes, and various other county taxes have continued to increase at alarming rates since 2007 even in the face of a bearish economy and persistent cost of living increases. The rate increase that is proposed puts an unnecessary burden on fixed income folks. If the sewer company is operating at a loss we need to know why and what controls are in place to prevent excessive rate increases in the future. Because right now there is quite a bit of tax and rate gouging going on around here without proper taxpayer/consumer representation. Right now there is not much of
