LETTER OF SUFFICIENCY

Dear Mr. Marks and Mr. Levie:

This letter (per section R14-2-103 B.7 of the Arizona Administrative Code) is to inform you that your application, originally received on June 30, 2014, found insufficient on July 25, 2014 and resubmitted with changes on August 25, 2014, September 8, 2014, September 17, 2014 and September 18, 2014 respectively, has now met the sufficiency requirements as outlined in Arizona Administrative Code R-14-2-103. Your utility has been classified as a Class “C” Utility.

Staff’s testimony is due to be docketed on or about February 2, 2015, and the ultimate due date of the Commission Order finalizing the case will be due on or about June 16, 2015. A subsequent Procedural Order will more specifically define a hearing date, these and other filing dates.

Chino Meadows II Water Co., Inc. has requested in the application to be processed and heard concurrently with its affiliate Granite Mountain Water Company (“GMWC”) W-02467A-14-0230. GMWC is a Class “D” Utility. Both affiliates are requesting a Procedural Conference to include a form of notice to be provided to its customers and a subsequent procedural schedule.
