**LETTER OF SUFFICIENCY**

Dear Mr. Marks and Mr. Levie:

This letter (per section R14-2-103 B.7 of the Arizona Administrative Code) is to inform you that your application, originally received on June 30, 2014, found insufficient on July 25, 2014 and resubmitted with changes on August 25, 2014, September 8, 2014, September 17, 2014 and September 18, 2014 respectively, has now met the sufficiency requirements as outlined in Arizona Administrative Code R-14-2-103. Your utility has been classified as a Class “D” Utility.

The Staff Report regarding this application should be docketed on or about December 3, 2014, and a Commission decision should be rendered on or before March 18, 2015, barring any substantial amendments to the filing or extraordinary events.

Granite Mountain Water Company, Inc. (“Company”) has failed to provide Customer Notice due to the request by the Company in the application to be processed and heard concurrently with its affiliate Chino Meadows II Water Company (“CMWC”) W-02370A-14-0231. CMWC is a Class “C” Utility. Both affiliates are requesting a Procedural Conference to include a form of notice to be provided to its customers and a subsequent procedural schedule. If these two cases are consolidated, then the above dates will be altered.
