
**NOTICE OF WITHDRAWAL OF
REQUEST FOR PROCEDURAL
CONFERENCE**

17 Valley Vista Property Owners Association, Inc. ("VVPOA") hereby withdraws its
18 June 24, 2014 request for a procedural conference in this consolidated proceeding. As
19 noted in Commission's Staff's July 17, 2014 response to the request, continued delay will
20 be "detrimental to the ratepayers, who would continue to pay the current higher rates until
21 a decision..." VVPOA is willing to address its other concerns in other proceedings, and
22 is primarily focused now on obtaining rate relief. As a non-profit organization, VVPOA
23 cannot continue to pay the current higher rates without having a severe negative impact to
24 its members. For these reasons, VVPOA withdraws its request, and strongly urges the
25 Commission's Hearing Division to issue its recommended opinion and order within the
26 next thirty (30) days.
