IN THE MATTER OF THE APPLICATION OF GRANITE MOUNTAIN WATER COMPANY, INC. FOR APPROVAL OF A RATE INCREASE.

DOCKET NO. W-02467A-14-0230

PROCEDURAL ORDER (Sets Procedural Conference)

BY THE COMMISSION:

On June 30, 2014, Granite Mountain Water Company, Inc. ("Granite Mountain" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for a rate increase. The application noted that Granite Mountain Water Company's affiliate Chino Meadows II Water Company ("Chino Meadows") also filed a rate application in a separate docket (Docket No. W-2370A-14-0231) on the same day. Granite Mountain requests that its application be processed and heard concurrently with Chino Meadows' application in order to assure that cost allocations will be consistent in the two cases. Granite Mountain requests that a procedural conference be held for a discussion of hearing dates and associated procedural deadlines. Granite Mountain states that to the extent necessary to accommodate the joint processing of the two applications, it waives the timeclock requirements set by the Commission's rules.

On July 24, 2014, the Commission's Utilities Division ("Staff") filed a Letter of Deficiency.

On July 25, 2014, Staff filed a Notice of Deficiency.

On August 8, Staff docketed a Notice of Filing indicating Staff's agreement to an extension of the deadline for correcting deficiencies in the application to August 25, 2014.

On August 25, 2014, Granite Mountain filed a Response to Letter of Deficiency.

On September 8, 17, and 18, 2014, Granite Mountain filed letters and supplemental documents.

On September 19, 2014, Staff filed a Letter of Sufficiency indicating that Granite Mountain's

1 application met the sufficiency requirements of A.A.C. R14-2-103, and classifying Granite Mountain  
2 as a Class D Utility.

3 A procedural conference should be convened in order to discuss the preparation for and  
4 conduct of this proceeding concurrently with the proceeding on the rate application filed by Granite  
5 Mountain's affiliate Chino Meadows II Water Company in Docket No. W-2370A-14-0231.

6 IT IS THEREFORE ORDERED that a **procedural conference** in the above-captioned matter  
7 shall commence on **October 2, 2014, at 2:00 p.m.**, or as soon thereafter as is practical, in Hearing  
8 Room No. 1 at the Commission's offices, 1200 West Washington, Phoenix, Arizona 85007.

9 IT IS FURTHER ORDERED that as agreed to by Granite Mountain Water Company, Inc.,  
10 the timeclock in this matter is suspended as necessary to accommodate the joint processing of this  
11 application with the rate application of its affiliate Chino Meadows II Water Company in Docket No.  
12 W-02370A-14-0231.

13 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized  
14 Communications) applies to this proceeding and shall remain in effect until the Commission's  
15 Decision in this matter is final and non-appealable.

16 IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules  
17 31, 38, and 42, and A.R.S. § 40-243 with respect to practice of law and admission *pro hac vice*.

18 IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance  
19 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Arizona  
20 Supreme Court Rule 42). Representation before the Commission includes appearances at all hearings  
21 and procedural conferences, as well as all Open Meetings for which the matter is scheduled for  
22 discussion unless counsel has previously been granted permission to withdraw by the Administrative  
23 Law Judge or the Commission.


