I, Nisa Nelson, hereby declare:

1. I am a resident of Arizona and an employee of Kent Maerki and Norma Jean Maule. I am over the age of eighteen and I am competent to testify regarding all the allegations made herein. If called upon to testify, I have personal knowledge of the following facts and would testify as follows:
2. I am one of two staff personnel who control and maintain Kent Maerki's appointments and scheduling.
3. Mr. Maerki's typical week that we schedule has included the following health related events:

- a. Three visits to the Jewish Community Center for cardio/physical workouts
  - b. One visit to Dr. Jack Wolfson's office—Mr. Maerki's cardiologist
  - c. Two visits to Dr. Michael Robb's office— Mr. Maerki's chiropractor
  - d. Two visits to MojoPhysio— Mr. Maerki's deep massage therapist
  - e. One visit to a lab to draw blood for Mr. Maerki's warfarin INR control
4. Immediately subsequent to Mr. Maerki's acute stroke on August 27, 2014, we began scheduling doctors and healthcare providers for Mr. Maerki at the directions of his doctors at Scottsdale Healthcare Hospital, his primary care doctors and referrals from referred doctors. These include the following, which are in addition to the events in item number 3:
- a. Dr. Seth Kaufmann, Neurologist, who referred Mr. Maerki to:
    - i. Dr. Patel for sleep study to determine if sleep apnea was a condition placing Mr. Maerki at risk for strokes
      1. First appointment—Monday, September 29<sup>th</sup> at 10:30 AM
    - ii. Dr. Alberty of Barrow Neurological Institute for neurological and psychological testing
      1. First appointment available—October 1<sup>st</sup> at 8:00 AM
    - iii. Scottsdale Healthcare Physical Neurological Therapy
      1. First appointment available—October 9<sup>th</sup> at 8:15 AM
    - iv. Simon Med Imaging
      1. First appointment available—September 29<sup>th</sup> at 8:15 AM
    - v. Laboratory for a battery of blood tests
      1. Scheduled and completed last week
5. We have been advised to expect additional appointment setting from time to time as the doctors determine throughout Mr. Maerki's rehabilitation.
6. We have been instructed to schedule Mr. Maerki's healthcare appointments as top priority, his personal resting time as the second priority and his

business appointment as lowest priority, all within a reasonable time period daily to allow for a low stress lifestyle.
