PROCEDURAL ORDER

**BY THE COMMISSION:**

On July 11, 2014, Green Acres Water Company ("Green Acres" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for an emergency rate increase for customers in the Company's service area in Yuma, Arizona.

On July 23, 2014, a Procedural Order was issued scheduling a procedural conference in this matter for July 29, 2014, at 10:00 a.m.

IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules 31, 38, 42 and A.R.S. §40-243 with respect to practice of law and admission *pro hac vice*.

IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Arizona Supreme Court Rule 42). Representation before the Commission includes appearances at all hearings and procedural conferences, as well as all Open Meetings for which the matter is scheduled for

1 discussion unless counsel has previously been granted permission to withdraw by the Administrative  
2 Law Judge or the Commission.

3 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,  
4 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at  
5 hearing.
