BY THE COMMISSION:

FINDINGS OF FACT

1. On June 20, 2014, the Arizona Corporation Commission ("Commission") approved the reinstatement of a portion of White Hills Water Co.'s ("White Hills" or "Company") Certificate of Convenience and Necessity ("CC&N") in Decision No. 74562.

2. On July 11, 2014, White Hills received a request to serve an area located outside its CC&N approved by Decision No. 74562.

3. On July 29, 2014, the Company filed a request to modify Decision No. 74562, pursuant to A.R.S. § 40-252, to permit the Company to extend its CC&N to include the area for which it had received a request for service.

4. Commission Utilities Division Staff filed a memorandum on August 12, 2014, wherein Staff stated that the Company has existing infrastructure in the area and thus it is in the best

1 position to serve the area. Staff's memorandum recommends granting the Company's request for an
2 extension of its CC&N.

3 4. White Hills' request was placed on the Commission's August 12, 2014 Staff Open
4 Meeting agenda, with notice and opportunity to be heard. After considering the Company's request,
5 the Commission voted to modify Decision No. 74562 by granting White Hills the additional territory
6 to its CC&N.

7 **ORDER**

8 IT IS THEREFORE ORDERED that Decision No. 74562 is hereby modified to include in
9 White Hills Water Co.'s, Certificate of Convenience and Necessity the area described by the
10 following legal description:

11 The West Half of the West Half of the Northwest Quarter of Section 21, Township 27
12 North, Range 19 West.


13 IT IS FURTHER ORDERED that all other aspects of Decision No. 74562 shall remain in




