RE: **Crimes Against Humanity**

Dear Commissioners,

A revealing sworn statement by microwave weapons expert, Dr. Barrie Trower, quoted below, relates to documents obtained under the Freedom of Information Act (FOIA). Even though extracts from published US Defense Intelligence Agency (DIA) documents confirmed the 1971 US Naval Medical Research Institute (NMRI) reference of 2300 research articles listing over 120 impairments and illnesses attributed to radiofrequency microwave radiation, Dr. Trower quoted FOIA DIA documents:

"If the more advanced nations of the West are strict in enforcement of stringent exposure standards, there could be unfavorable effects on industrial output and military functions... It was suggested that governments in the West chose a safety level compatible to industrial output and military function. The governments that adopted the thermal level only denied and still to this day deny any adverse effect from subthermal levels."

Dr. Barrie Trower also referenced the reason for the decision to disregard ***stringent exposure levels***:

"in order to protect industrial profit and military function, and to avoid litigation from military employees."¹

Dr. Barrie Trower's revealing FOIA references highlight sociopathic 'Smart' decisions made by military-industrial interests: cold-blooded reasoning for forcefully exposing United States populations, and everyone else, to dangerous pulsed microwave wireless technologies. Resulting 'Smart' activity has been a *serious attack on human dignity* with callous indifference and treasonous disregard for the safety and human rights of everyone targeted by the intentionally unregulated use of biologically harmful 'Smart' pulsed microwaves in the 900 MHz and 2.4 GHz range.

Instead of **strict enforcement of stringent exposure standards** that humanity, all animals and plants deserve, the choice of the military-industrial elite has been ***dehumanizing enslavement*** to unsafe 'Smart' technologies that have involved ***human experimentation, torture*** and ***murderous inhumane acts***. **Crimes Against Humanity**, as defined by the **Rome Statute of the International Criminal Court Explanatory Memorandum**, reach the threshold of 'crimes against humanity' only if they are part of a **widespread or systematic practice**.^{2 3}

President Dwight D. Eisenhower, the only general to be elected president in the 20th century, warned us, in his 1961 farewell **Military-Industrial Complex Speech**:

"In the councils of government, we must guard against the acquisition of unwarranted influence, whether sought or unsought, by the military-industrial complex. The potential for the disastrous rise of misplaced power exists and will persist.

We must never let the weight of this combination endanger our liberties or democratic processes. We should take nothing for granted. Only an alert and knowledgeable citizenry can compel the proper meshing of the huge industrial and military machinery of defense with our peaceful methods and goals, so that security and liberty may prosper together."



Amended Declaration of Barrie Trower⁶

Selected portions from 26 page document: 2 pages.

According to Dr. Barrie Trower, former Royal Navy microwave weapons expert, "microwave or 'radiowave sickness' was first reported in August 1932 with the symptoms of severe tiredness, fatigue, fitful sleep, headaches, intolerability and high susceptibility to infection. By 1971, the **US Naval Medical Research Institute (NMRI)** referenced 2300 research articles listing in excess of 120 impairments and illnesses attributed to radiofrequency and microwave radiation.⁷

In 1975, after an extensive study, the United States DIA warned all of its personnel of the risk from low-level microwaves including illnesses ranging from microwave sickness (flu like symptoms, depression, suicidal tendencies)

to cancers and leukemia. *Biological effects of electromagnetic radiation (radiowaves and microwaves) – Eurasian Communist Countries*, Defense Intelligence Agency: DST-1810S-074-76, March (1976).

During the Cold War, the Russian Embassy microwaved the United States Embassy in Moscow with low-level microwaves for many years from across the road... After changes of staff for serious neurologic impairments, miscarriages, multiple cancers / leukemias and other illnesses to both male and female employees and their children, the late John R. Goldsmith, M.D., was invited to investigate this matter. His investigative report on this incident showed that continuous, long-term low-level microwaves were responsible for those illnesses.
