

**MOTION AND REQUEST  
FOR PROCEDURAL  
CONFERENCE**

24 On March 2, 2005, Circle City Water Company LLC (“Circle City” or  
25 “Company”) filed an application for an extension of its Certificate of Convenience and  
26 Necessity (“CC&N”) with the Arizona Corporation Commission (the “Commission”) to  
27 provide public water service to a proposed developed known as Lake Pleasant 5000 (the  
28 “Project”) in Maricopa County. The Project was described in two sections as Phase I and  
29 Phase II.

30 On November 19, 2013 Circle City filed an application with the Commission  
31 requesting approval to delete portions of its CC&N as extended by Decision No. 68246  
32 and to delete the Decision’s requirement for the Company to demonstrate in its next rate  
33 case filing that its existing customers have been positively impacted by the addition of the  
34 new water facilities necessary to serve the extension area.

1 On December 11, 2013 and January 9, 2014, Lake Pleasant 500 ("LP5K") and  
2 Rex G. Maughan and Ruth G. Maughan, Trustees of the Maughan Revocable Trust of  
3 2007 ("MRT"), respectively, filed an application to intervene.

4 On December 13, 2013 and March 12, 2014, by Procedural Order, LP5K and  
5 MRT were granted intervention, respectively.


6 In April 2014 both Circle City and LP5K provided additional documentation to  
7 support their positions pursuant to separate data requests by the Commission.

8 On October 17, 2014 Commission Staff issued its Staff Report which  
9 recommended Commission approval of its Motion, in part, and denied its Motion in part.

10 Accordingly, Circle City respectfully requests the Commission's Hearing  
11 Division's issue a procedural order establishing a schedule for the purpose of setting forth  
12 a time for further filings, discovery, and hearing of the matters denied by the Commission  
13 in its Staff Report.


