

MOTION FOR PROCEDURAL ORDER

The RESIDENTIAL UTILITY CONSUMER OFFICE ("RUCO") hereby requests that the Arizona Corporation Commission ("Commission") issue a Procedural Order in this matter.

UNS Electric filed its Application on December 31, 2013. RUCO applied for intervention on February 25, 2014, and was granted intervention on March 7, 2014. On October 28, 2014, the Commission Staff filed the Direct Testimony of Gerald Becker. No Procedural Order was ever issued scheduling a date for filing testimony. RUCO requests a Procedural Order be issued setting forth a procedural schedule for this case. Clearly, a procedural schedule would provide procedural guidelines and a more efficient manner in handling this case.
