PROCEDURAL ORDER

BY THE COMMISSION:

The hearing in the above captioned matter convened on September 4, 2014.

On October 9, 2014, Naco Water Company, LLC. ("NWC" or "Company") filed several Post-Hearing documents, including, *inter alia*, a matrix of rate base issues.

Currently, according to the Company's Post-Hearing filing, NWC proposes an Accumulated Depreciation balance of \$730,979. According to Staff's schedules, Staff is recommending an Accumulated Depreciation balance of \$740,486. The record does not show the parties' calculation of the Accumulated Depreciation balances. In addition, having the parties provide electronic copies of their billing determinants/bill counts used to prepare their rate designs will also assist the preparation of an Order in this matter. The request for the information described herein below is not intended to require the parties to create new documents, but to provide the underlying support/calculations for their recommendations.

IT IS THEREFORE ORDERED that the parties shall file with Docket Control by November 7, 2014, support for their recommended Accumulated Depreciation balances showing the annual changes that reconcile the authorized balance in the prior rate case to the proposed amount in this rate case with calculations showing the plant balances by account and the depreciation rates applied each year; and if an **electronic version** of such Accumulated Depreciation reconciliation is available (by **USB Drive or other appropriate form**), the parties shall provide it to the Hearing Division by the same date.

1 IT IS FURTHER ORDERED that the parties shall also provide to the Hearing Division by  
2 November 7, 2014, an electronic version of the billing determinants/bill counts utilized to  
3 formulate their rate designs.

4 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive  
5 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


