**STAFF'S RESPONSE TO MOTION TO
EXTEND DEADLINE TO FILE
EXCEPTIONS AND RESCHEDULE
HEARING**

Arizona Corporation Commission Staff ("Staff") hereby responds to the motion of Truxton Canyon Water Co. ("Truxton" or "Company") to extend the deadline to file exceptions and to reschedule the hearing herein. Exceptions to the Recommended Opinion & Order ("ROO") issued on October 21, 2014, are due on October 30, 2014. This case has been pending for more than three years. The issues were fully addressed at hearing in February 2014, and were thoroughly briefed by the parties. Therefore, Staff does not agree that any extension of time to respond is warranted based on the above.

However, to the extent the Company's representative is unable to attend, Staff does not oppose resetting this matter. Staff notes that a contingent Open Meeting date is set for November 13, 2014 which, if this item is deliberated at that time, would allow the recommended rate decrease to still take effect December 1, 2014.


