PROCEDURAL ORDER (Schedules Procedural Conference)

BY THE COMMISSION:

On September 20, 1961, the Arizona Corporation Commission ("Commission") issued Decision No. 33424, in which Arizona Water Company ("AWC") was granted a certificate of convenience and necessity ("CC&N") to serve various areas in Gila County, Arizona.

On August 18, 2014, the City of Globe ("Globe" or the "City") filed a Petition to Amend Decision 33424 Pursuant to A.R.S. § 40-252, requesting that the Commission amend Decision No. 33424 to remove the portions of AWC's CC&N that the City states it has provided water service to since the early 1900s.

At Commission's Staff Meeting on October 16, 2014, the Commissioners voted to reopen Decision No. 33424 pursuant to A.R.S. § 40-252, and instructed the Commission's Hearing Division to conduct further proceedings on the matter.

Therefore, it is appropriate to schedule a procedural conference to establish a procedural schedule for this matter.

IT IS THEREFORE ORDERED that a procedural conference shall be held on November 10, 2014, at 2:00 p.m., or as soon thereafter as is practical, at the Commission's office, 1200 West Washington Street, Hearing Room No. 1, Phoenix, Arizona, 85007.

IT IS FURTHER ORDERED that Globe, AWC, and Staff each shall be prepared at the procedural conference to make recommendations regarding the process and schedule that should be

1 followed for this matter, which shall include, but is not limited to, recommendations as to notice,
2 discovery, and possible hearing dates.


3 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized
4 Communications) applies to this proceeding as the matter is now set for public hearing, and shall
5 remain in effect until the Commission's Decision in this matter is final and non-appealable.

6 IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules
7 31, 38, ad 42 and A.R.S. §40-243 with respect to the practice of law and admission *pro hac vice*.

8 IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance
9 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the
10 Rules of the Arizona Supreme Court). Representation before the Commission includes the obligation
11 to appear at all hearings, procedural conferences, Open Meetings for which the matter is scheduled
12 for discussion, unless counsel has previously been granted permission to withdraw by the
13 Administrative Law Judge or Commission.

14 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
15 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
16 hearing.
