

Decision No. 74364 (February 26, 2014) requires that Water Utility of Greater Tonopah ("WUGT") file its Central Arizona Groundwater Replenishment District ("CAGR") semi-annually, consistent with the Settlement Agreement and the Decision, by April 30, 2014.

To date, WUGT has not enrolled in CAGR. No funds have been collected pursuant to the CAGR District Tariff and no withdrawals made. At such time as WUGT enrolls in CAGR, the utility will notify the Commission.
