FINDINGS OF FACT

1. On July 14, 2014, Re-Invent Telecom, LLC (“Re-Invent” or “Applicant”) submitted an Application requesting rescission of the \$235,000 performance bond requirement contained in Decision No. 72673.

Background

2. On November 17, 2011, in Decision No. 72673, the Arizona Corporation Commission (“Commission”) ordered Re-Invent to procure a performance bond or irrevocable sight draft letter of credit (“ISDLOC”) equal to \$235,000. On February 8, 2012, Re-Invent delivered an original letter of credit to the Commission’s Business Office in the amount of \$235,000. Staff has confirmed the Business Office is in possession of this original document.

1 **Compliance**

2 3. According to the Corporations Division, Re-Invent is in good standing. The
3 Compliance Section of the Utilities Division reports that Re-Invent is currently in compliance. The
4 Consumer Services Section of the Utilities Division reports there have been no complaints or
5 opinions about Re-Invent for the period of January 1, 2011 to the present.

6 **Staff Recommendations**

7 4. The Commission has, in appropriate circumstances, relieved telecommunications
8 providers of the obligation to maintain a performance bond or ISDLOC. Staff recommends Re-
9 Invent be relieved of the \$235,000 performance bond or ISDLOC obligation contained in Decision
10 No. 72673.

11 5. The Applicant states that in order to release the letter of credit, it is sufficient for the
12 Commission to include in an ordering paragraph language authorizing the Applicant to cancel, rescind,
13 discontinue and be released from the performance bond or ISDLOC required by Decision No. 72673.

14 6. Re-Invent indicates in the Application the letter of credit should be released and
15 returned to the following name and address:

19 CONCLUSIONS OF LAW

20 1. Re-Invent Telecom, LLC, is a public service corporation within the meaning of Article
21 XV of the Arizona Constitution.

22 2. The Commission has jurisdiction over Re-Invent Telecom, LLC, and the subject
23 matter in this filing.

24 3. The Commission, having reviewed the filing and Staff's Memorandum dated
25 September 25, 2014, concludes that it is in the public interest to approve the Re-Invent Telecom,
26 LLC, Application as proposed and discussed herein.


