BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission (“Commission”) finds, concludes, and orders that:

FINDINGS OF FACT

1. In Commission Decision No. 65980 (June 17, 2003), the Commission granted The Antigua Group, Inc. (“Antigua” or “Applicant”) a Certificate of Convenience and Necessity (“CC&N”) to provide customer owned pay telephone (“COPT”) services in Arizona.
2. On September 2, 2014, Antigua filed an application with the Commission requesting approval to cancel its CC&N to provide COPT services in Arizona.
3. On September 24, 2014, the Commission’s Utilities Division (“Staff”) filed a Memorandum in response to Antigua’s application to cancel its CC&N. The application indicated Antigua no longer provides COPT services in the State of Arizona. Staff states Mr. Keith Kealer indicated he was authorized to file the application on behalf of the Applicant. Further, Staff states that the Commission’s Consumer Services Section reported that no complaints, inquiries, or opinions have been filed against Antigua. According to Staff, the Applicant is in good standing with the

1 Commission's Corporations Division and the Commission's Compliance Section reports that no
2 compliance items or delinquencies have been reported for the Applicant.

3 4. Staff recommends approval of Antigua's application to cancel its CC&N.

4 5. Staff's recommendation to approve Antigua's application for cancellation of its
5 CC&N is reasonable and should be adopted.

6 **CONCLUSIONS OF LAW**

7 1. Applicant is a public service corporation within the meaning of Article XV of the
8 Arizona Constitution and A.R.S. §§ 40-281 and 40-282.

9 2. The Commission has jurisdiction over Antigua and the subject matter of the
10 application.

11 3. The cancellation of Antigua's CC&N to provide COPT services in Arizona is in the
12 public interest.

13 4. Antigua waives its right to notice and a hearing in this matter.

14 5. Staff's recommendation is reasonable and should be adopted.


