

I am writing to you as a resident of the community of Verrado and the Agua Fria district to respectfully request your support in the issue of EPCOR wastewater districts. I know that, in the 2012 vote, you opposed deconsolidation, and I hope we can count on your support once again.

We believe that full consolidation of EPCOR's wastewater districts is the very best policy decision ACC can make. It not only grants the rate relief Agua Fria residents so desperately need, it also meets with the expectations of the Arizona Constitution and aligns with the way other utilities are priced. It provides economy of scale and promotes efficiency on the part of the Company.

RUCO's director, Mr Quinn, has been vocal in his opposition to a speedy decision, citing the need for a full rate case first, but his own arguments in other cases provide the procedural path to deliver exactly the relief we need. He has argued that an interim rate decision is justified in emergency circumstances, and that's just what we have on our hands: a rate emergency. You are well aware that, with the January increase, our rates in Agua Fria will rival the highest in the nation. Our neighbors are selling their homes and new customers are declining to buy, simply because of the water bill.

EPCOR has taken the unprecedented step of advocating a position before the Commission. This is a clear signal of the urgency of the matter. Certainly a rate case is justified, but customers should not bear the burden for another year and a half while that process is underway.

The decision has had crippling effects on Agua Fria ratepayers, and it is a decision that must be corrected. Please help us correct it. 





As a resident of Verrado in the Agua Fria wastewater district, I am writing to urge you to support a vote for FULL CONSOLIDATION of the five EPCOR districts and for immediate rate relief to those of us who are facing some of the highest wastewater bills in the nation.

The Residential Utilities Consumer Office (RUCO), and other parties, would rather stall this process and delay any decision until a full rate case can be completed, an expensive venture that would delay relief a year or more. The irony here is that RUCO's argument also presents the biggest flaw in their thinking. Specifically, there is no rate case before the Commission at this time for wastewater, because EPCOR is ALREADY authorized to receive the total revenue described in their proposals. The decision on that point has already been made by the ACC.




