On September 4, 2014, Halcyon Acres Annex No. 2 Water Company, Inc.'s ("Company") filed with the Arizona Corporation Commission ("Commission") an application pursuant to A.R.S. § 40-252 to amend Decision No. 48650 (January 16, 1978) requesting that the Commission consider revision of the legal description of the Company's certificated area ("Application").

The Commission approved the A.R.S. § 40-252 Application on October 16, 2014, and directed the Commission's Hearing Division to set a procedural schedule.




