On October 7, 2014 in accordance with A.A.C. R14-2-107(C)(5) Duncan Valley Electric Cooperative, Inc. ("DVEC") caused a notice to be mailed to its customers via First Class Mail stating that the Cooperative intended to file a streamlined rate case on or about October 27, 2014, to increase rates and charges pursuant to A.R.S. § 40-250 and A.A.C. R 14-2-107, the Arizona Corporation Commission's rule authorizing the filing of streamlined rate applications by electric and natural gas cooperatives. The Notice established November 7, 2014 as the deadline for customers to file objections and/or requests to intervene in accordance with A.A.C. R14-2-107(F)

On October 28, 2014 DVEC filed its application requesting the establishment of new rates under the streamline procedure established by A.A.C. R14-2-107 (the "Rule"). As of this date, the Commission had received no comments from customers in opposition to the Application.

As of the close of business on November 7, 2014, the Commission had received no comments from customers in opposition to the Application which is below the permitted number of 106 objections for a streamlined rate case as described in DVEC's application.
