RE: IN THE MATTER OF THE APPLICATION OF RADICAL SYSTEM SOLUTIONS, INC FOR APPROVAL FOR CANCELLATION OF ITS CERTIFICATE OF CONVENIENCE AND NECESSITY.  
(DOCKET NO. T-20642A-14-0352)

On September 29, 2014, Ms. Sharon R. Warren filed an application on behalf of Radical System Solutions, Inc. ("RSSI" or "Applicant") to cancel its Certificate of Convenience and Necessity ("CC&N") to provide customer owned pay telephone ("COPT") service. The Commission granted the Applicant a CC&N to provide COPT service in Decision No. 71265, dated September 3, 2009.

In the application, Ms. Warren indicates she is the authorized person to file the application and that RSSI no longer provides, or ever did provide, COPT service in the State of Arizona. Further, the Applicant waives its right to notice and a hearing in order to cancel the CC&N.

The Compliance Section of the Utilities Division indicates that the Applicant is in compliance. The Consumer Services Section has not had any complaints, opinions or inquiries about RSSI. RSSI is current in filing its Utilities Annual Report. The Corporations Division reports RSSI is in Good Standing.

Staff recommends that the application to cancel the CC&N be approved. Upon cancellation of its CC&N, the Applicant will not be authorized to provide COPT telecommunications services in the state of Arizona and therefore, will not be subject to any of the requirements of Decision No. 71265.
