

As a resident of Sun City West, I have grave concerns regarding the EPCOR wastewater consolidation proposal.

While the initial increase for SCW appears moderate, the requirement that we subsidize all future infrastructure costs for surrounding communities changes everything. We in the Sun Cities chose our community based, in large part, on the cost involved to live here. The costs examined were mainly in the areas of taxes and utilities; to suddenly change the way our water bills are computed should not be allowed.

When EPCOR bought the water company a few short years ago, they were aware of the infrastructure's condition, and should have figured that into the price they paid for the company. We should not have to pay for their shortsightedness. Nor should we be asked to pay to increase their profit margin.

There are better ways to handle this situation and it is imperative that the ACC stop the proposed consolidation until all options have been explored. The communities impacted need to have the chance to explore the issues and provide input on a workable solution.

EPCOR's proposal gives them, a foreign company who shouldn't have control over our water to begin with, carte blanche in handling this precious resource.







The aforementioned Dockets were issued decisions by the Commission and closed in 2012. One such decision was to reject the concept of "full consolidation" of the EPCOR water/wastewater districts.

On March 13, 2014 and April 10, 2014 (Docket Dates), the Arizona Corporation Commission (ACC) received petitions from the communities of Corte Bella, Cross River, Dos Rios and Coldwater Ranch requesting remedy for their exorbitant high wastewater rates. The consolidated signatory count was approximately 3,400. The petitions clearly listed their expectations. In no case was there mention nor expectation thereof for "full consolidation" of the EPCOR wastewater districts nor any mention of any action relating to the Sun City wastewater district.

There was no complaint or mention of "full consolidation" until mentioned on page 6, item (3), which is contained in ACC's Staff recommendation document dated July 8, 2014.

The matter of "full consolidation" of EPCOR water/wastewater districts was ruled not in the best interest of the public in 2012. It is improper to be discussing and/or voting to overturn a previous decision without a full rate case and must be removed from the current proceedings.
