Clearly the benefits of city-wide infrastructure benefit the city as a whole and the best way to distribute costs is among the largest base of ratepayers. Our phone calls go to the same service number. A service technician doesn't handle solely Agua Fria calls with Agua Fria parts. As Agua Fria customers, our nearest customer service office is in Sun City, officially another district. The actual operation of these districts are unified in all aspects other than billing.

Among the districts, only Agua Fria has significant opportunity for growth. Our sister districts are completely built out. The only chance to increase the ratepayer base for the areas EPCOR services and further defray costs of operations for everybody is through growth in the Agua Fria district. The current, prohibitive costs of wastewater are not only stunting growth in the area, they are actually driving existing ratepayers out.

The real impacts of the 2012 decision to deconsolidate have been, frankly, disastrous to Agua Fria residents. No amount of conservation will do away with a \$106 wastewater charge (soon to be \$121), and we find ourselves making choices about which essentials to do without or whether to leave altogether. Much has been made of retirees on "fixed incomes." I would urge you to consider the fact that virtually everyone is dealing with earning potential that cannot be increased at will.

Full consolidation is the right decision, not just for Agua Fria, but for all EPCOR customers, who will, sooner or later, be in need of subsidization to offset the costs of essential infrastructure upgrades, installations and improvements. One company, one district, one rate. It's simply the fair thing to do. Water is life, and should not be held hostage in such a manner. Thank you for your consideration in this matter.
