**Customers of Table Top Telephone Company, Inc.**  
**Notice of Rate Increase**  
**Docket No. T-02724A-13-0416**

On November 13, 2014, the Arizona Corporation Commission (“Commission”) issued Decision No. 74830. This Decision authorized Table Top Telephone Company, Inc. (“Table Top”) to increase Table Top’s base rates for residential local exchange service from the current tariffed rate of \$14.00 to \$16.00 effective December 1, 2014.

The new \$16.00 rate is the first of two step increases authorized by the Commission pursuant to a June 10, 2014, Federal Communications Commission (“FCC”) Order. The FCC Order established a residential local service rate floor of \$20.00 but provides for a partial phase-in to the rate floor in two steps.

Step	Effective Date	Rate	Comment
1	December 1, 2014	\$16.00	plus Zone 2 charge if appropriate
2	June 1, 2016	\$18.00	or the new residential local service rate floor established by the FCC if lower.

In addition to the increase in the basic local access line rate, effective December 1, 2014:

- The current Zone 1 charge of \$0.80 will be eliminated; and
- The current Zone 2 charge of \$2.80 will be reduced to \$0.80.

Thus, under Table Top's rate structure:

- Most customers will see an increase in their base monthly rate from \$14.00 to \$16.00;
- Zone 1 customers will see an overall increase in their total monthly charge (base rate plus zone charge) from \$14.80 to \$16.00; and
- Zone 2 customers’ total monthly charge (base rate plus zone charge) will remain at \$16.80.

The FCC requires Table Top to implement these residential local service rate increases or Table Top will lose Federal Universal Service Funding on a dollar-for-dollar basis to the extent that its rates are below the FCC’s rate floors. The purpose of Federal Universal Service Funding is to keep local service rates affordable.
