



Notice of Rate Increase

7 On October 24, 2014, the Commission issued Decision No. 74775. This Decision authorized South Central
8 Utah Telephone Association, Inc. ("Company") to increase the Company's rates for residential local exchange
9 service from the current tariffed rate of \$14.00 to \$16.00 effective December 1, 2014. The new \$16.00 rate is the
10 first of three step increases authorized by the Commission pursuant to a June 10, 2014 Federal Communications
11 Commission ("FCC") Order. The FCC Order established a residential local service rate floor of \$20.00 but provides
12 for a phase-in of the rate floor in three steps. There will be another step increase to \$18.00 (or the new rate floor
13 established by the FCC if lower) effective June 1, 2016. The final step increase will become effective June 1, 2017,
14 and will be set at the lower of \$20.00 or the FCC's new residential local service rate floor. The FCC requires the
15 Company to implement these residential local service rate increases or the Company will lose Federal Universal
16 Service Funding on a dollar for dollar basis to the extent that its rates are below the FCC's rate floors. The purpose
17 of Federal Universal Service Funding is to keep local service rates affordable.
