UNS Energy Corporation (“UNS Energy”), Tucson Electric Power Company (“TEP”), UNS Electric, Inc. (“UNSE”) and UNS Gas, Inc. (“UNSG”) (collectively, “Companies”), through undersigned counsel, hereby request an extension to file their list of “all waivers of Commission Rules that remain in effect as well as any conditions imposed on the utilities as a result of other prior Commission Orders.”¹ Presently, Decision No. 74689 (August 12, 2014) requires the compliance list to be filed on December 10, 2014. The Companies request that an extension to file the compliance report until January 16, 2015 due to several circumstances, including the extensive nature of the compliance filing and other ongoing Commission proceedings that involve personnel working on the filing.

WHEREFORE, the Companies request that the December 10, 2014 filing date for the waivers and conditions list be extended until January 16, 2015.

¹ In the compliance filing, the Companies must also address whether the waivers and conditions are necessary and in the public interest.
