

ORDER

BY THE COMMISSION:

13 Having considered the entire record herein and being fully advised in the premises, the Arizona
14 Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

15 1. On December 2, 1997, Teleglobe USA, Inc. ("Applicant") filed with the Commission an
16 application for a Certificate of Convenience and Necessity ("Certificate") to provide resold
17 telecommunications service in the State of Arizona.
18

19 2. In Decision No. 58926 (December 22, 1994), the Commission found that resold
20 telecommunication providers ("resellers") were public service corporations subject to the jurisdiction of
21 the Commission.

23 3. In Decision No. 59124 (June 23, 1995), the Commission adopted A.A.C. R14-2-1101
24 through R14-2-1115 to regulate resellers.

25 4. Applicant is a Delaware corporation, qualified to conduct business in Arizona since 1998.

26 5. Applicant is a switchless reseller which will purchase services from AT&T, MCI, Sprint,
27 Worldcom and other carriers.

28 6. On May 15, 1998, Staff filed a Staff Report, recommending approval of the application
without a hearing.

1 Applicant is in the public interest.

2 5. Applicant is a fit and proper entity to receive a Certificate for providing competitive
3 interLATA/intraLATA reseller services in Arizona.

4 6. Staff's recommendations in Findings of Fact No. 9 are reasonable and should be adopted.

5 **ORDER**

6 IT IS THEREFORE ORDERED that the application of Teleglobe USA, Inc. for a Certificate of
7 Convenience and Necessity for authority to provide competitive interLATA/intraLATA resold
8 telecommunications services except local exchange services shall be, and the same is, hereby granted.

9 IT IS FURTHER ORDERED that Teleglobe USA, Inc. shall comply with the Staff
10 recommendations set forth in Findings of Fact No. 9.

11 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
