CHAPARRAL CITY WATER COMPANY'S REQUEST FOR ORDER *NUNC PRO TUNC*

Through this filing, Chaparral City Water Company ("CCWC") respectfully requests that Decision No. 74585 (the "Decision") be amended *nunc pro tunc* to address one minor error in the Decision. After conferring with Commission Staff, CCWC has determined that the specific language of the Decision indicates that the additional \$0.0573 per kgal charge only applies to the "third tier commodity rate". Although this charge is incorporated into the highest block commodity rate for all residential and commercial customer classes, that highest block is the second tier for all meter sizes other than the 3/4 inch meter residential and commercial class. Accordingly, CCWC respectfully requests that the Commission amend the Decision *nunc pro tunc* to revise references to the "third tier commodity rate" to read "the highest block commodity rate".


