STATUS UPDATE

In accordance with the Procedural Order dated December 10, 2014, the parties in the above captioned docket submit a joint filing as to the status of the settlement discussions.

After the November 10 Procedural Conference, all the parties remained in the hearing room to discuss potential settlement. Based upon that discussion, LP5K and Maughan Revocable Trust of 2007 ("MRT") made an offer to Circle City Water Company ("CCWC") in an attempt to settle the matter. CCWC responded with comments and questions to LP5K and MRT regarding the offer. Due to the holidays, LP5K and MRT have not yet responded to CCWC but intend to within the next few weeks. Based upon the potential for settlement, the parties request the procedural schedule be suspended. CCWC is supposed to provide notice to its customers by Jan 2, 2015 but would request the notice be stayed at this time as well. The parties will notify the hearing division, via a status update in the docket, once a settlement has been reached or, in the alternative, that settlement could not be reached and request a new procedural schedule.


