1 **APPLICANT'S MOTION TO TERMINATE NOTICE AND MOTION FOR**
2 **LEAVE OF COUNSEL TO WITHDRAW**

3 Applicant Tusayan Water Development Association, Inc. ("Tusayan"), through
4 counsel, hereby moves to terminate its status in the above dockets. Under the terms of a
5 settlement agreement approved by the Commission, Tusayan's Certificate of
6 Convenience and Necessity was cancelled, a replacement Certificate of Convenience and
7 Necessity was issued to Hydro-Resources, Inc. ("Hydro"), and Tusayan was required to
8 terminate its corporate existence and dissolve. Tusayan has filed Articles of Dissolution
9 with the Corporations Division, and has terminated its business. Tusayan has no further
10 need to be involved or served with further filings in this matter since its corporate
11 existence is terminated. Tusayan's principals and counsel undersigned will continue to
12 facilitate and confirm its performance of the settlement agreement. However, its
13 involvement in the public proceedings before the Commission should no longer be
14 required. Correspondingly, counsel undersigned seeks leave of the Commission to
15 withdraw from further representation of Tusayan.
