BY THE COMMISSION:

FINDINGS OF FACT

1. Gold Canyon is engaged in providing sewer service within portions of Maricopa County, Arizona, pursuant to authority granted by the Arizona Corporation Commission.

2. The Commission issued Decision No. 69664 (June 28, 2007) granting a rate increase to Gold Canyon Sewer Company ("Company"). Pursuant to that Decision, Staff was ordered to "conduct annual odor detection site visits and provide a report in this docket by December 31 of each year, as a compliance measure, with the first report to be filed by no later than December 31, 2007." Staff requests that the requirement to conduct annual odor detection site visits and the filing of a compliance report be discontinued.


ORDER


