BY THE COMMISSION:

On November 13, 2014, the Commission entered Decision No. 74827 in the above captioned matter. Respondents Seed Corporation and Randall and Marilyn J. Simonson (“Respondents”) filed a timely request for rehearing of Decision No. 74827. On December 2, 2014, pursuant to A.R.S. § 44-1974, the Commission granted rehearing only for the limited purpose of allowing more time for further consideration of Respondents’ request that would have otherwise have been deemed denied by operation of law.

Respondents’ request for rehearing was scheduled for further consideration at the Commission’s December 11, 2014, Open Meeting, and Respondents were provided notice and an

1 opportunity to be heard. Respondents appeared at the December 11, 2014, Open Meeting and were
2 duly heard by the Commission concerning their request for rehearing. After further discussion and
3 full consideration of these matters, including full consideration of the extensive docket that reflects
4 the evidentiary proceedings herein, the Commission finds and determines that it is in the public
5 interest to deny the Respondents' request for rehearing of Decision No. 74827.


6 **ORDER**
