The purpose of this letter is to correct a current discrepancy with respect to certain information appearing within (i) the prepared Direct Testimony of Thomas J. Bourassa and (ii) Schedule H-3 at page 3 of the Application accompanying Mr. Bourassa's testimony, as previously filed in the above-referenced docket.
